The students are hereby instructed to submit the whole project on **Computerised Accounting and e-Filing of Tax Returns** (of 80 marks) in a single pdf file not exceeding 20MB.

Students must answer all the following questions in their project report.

Computerised Accounting

Answer the following Questions:

- i. What are the applications of computer in Accounting? Write the steps of company creation in Tally software?
- ii. What are the different modes of passing journal in Tally software? Explain the utility of each of them and also mention the shortcut key.

e-Filing of Tax Returns



Answer the following Questions:

- iii. Describe various ITR forms to fill-up taxes in India? In order to save tax, where do we need to invest?
- iv. Mr. Y earned Rs 1.5 lakh per month in the financial year 2019-20. He availed the full INR 1.5 lakh limit of Section 80C through a combination of contribution to EPF and LIC premium. Besides this, he bought health insurance, for which he paid a premium of Rs 25,000 that he claimed as tax deduction under Section 80D. Also, to save more taxes from his salary, he made additional investments of Rs 30,000 in NPS. He also claimed a LTA amount of Rs 25,000, which is tax exempted. Moreover, he is entitled to have HRA exemption to the tune of INR 50,000. Show the step-by-step e-filing statement of Mr. Y in the old tax regime for the FY 2019-20 using MS-Excel.

- S. All the students must submit their project reports in digital format only. There is no requirement to submit any hard copy of the project reports.
- T. The date and mode of conduction of viva-voce for Project Work (CC 6.1 Ch) will be informed to the students shortly through notice in the college website.
- U. Students must duly sign digitally in the Students' Declaration page of their respective project report before submission of the Project Work in the College portal.
